

Data protection statement

Data protection: your rights are our commitment

You can rest assured that any personal data you supply will be protected and safeguarded: when processing data of a personal nature GoBali (Go Abroad Study Programs) takes individual privacy very seriously indeed and this is something that is built into every one of our business procedures.

We would therefore like to take this opportunity to set out the basic rules that govern the way in which we handle personal data. This statement, along with additional information on the acquisition, processing and use of personal data, will always be included whenever we make a request for information of this kind.

Information that we acquire

It is possible to make use of practically the entire GoBali (Go Abroad Study Programs) website without being asked to supply personal data of any kind. There are however a few products and services available on our web pages that require you to submit data of a personal nature.

When using internet services provided by GoBali (Go Abroad Study Programs) the GoBali (Go Abroad Study Programs) internet server (web server) will automatically display and analyse technical access data . These data cannot however be allocated to a specific person, which ensures the anonymity of the individual user.

Technical access data

These data include for example information on the internet browser and operating system, the domain name of the website that generated the visit to our internet pages, the average duration of the visit and the information pages activated in our website. When individual internet pages are called up these data are relayed to our web-server by your internet browser.

Some of our internet areas also contain cookies. These are small data files that an internet server can send to your computer. During the period of your visit to our internet site these cookies can identify your computer or help make it easier for you to use our internet pages. You can configure your internet browser in such a way that you are given the option of accepting or rejecting cookies. More information on this can be found in the 'help system' of your internet browser.

We use this technical access information to increase the appeal and user-friendliness of our internet pages, to improve its content and to help identify any technical problems that may arise.

Personal data

We only collect, process and use personal data that has been expressly provided by you. Such information may for example be obtained in connection with an enquiry or survey or may be the result of an initial approach made by you. Data are also collected as a general rule as part of the application process.

We further require personal data from you when you want to make use of certain internet-specific services provided via the internet pages of GoBali (Go Abroad Study Programs) – as and when these are offered. Such services include for example newsletters and forum opportunities. If you opt to take advantage of offers of this kind you will be provided in each



case with advice and information on the nature and scope of the data required for the use of the said services.

Protecting the personal privacy of children on the internet

GoBali (Go Abroad Study Programs) is particularly concerned about protecting children who are using internet services. GoBali (Go Abroad Study Programs) therefore advises all parents and guardians to ensure that their children act in a safe and responsible manner when giving out personal data on the internet.

Children should not submit personal data to GoBali (Go Abroad Study Programs) without first obtaining explicit consent from their parents or guardian.

How we use your data

GoBali (Go Abroad Study Programs) undertakes to respect current data protection laws when collecting, processing and using any personal data submitted as a result of your internet visit.

We shall only use your personal data for the purposes set out in this data protection statement (for example for application, processing requests and providing internet services). Moreover, we shall only collect, process and use personal data when this is necessary to protect the valid business interests of GoBali (Go Abroad Study Programs).

GoBali (Go Abroad Study Programs) can forward your personal data received from you to our business partners for marketing purposes, billing and accounting purposes and organisational purposes.

GoBali (Go Abroad Study Programs) will not disclose to any other third parties any personal data received from you without first obtaining your explicit consent.

Disclosure, modification and deletion of your data

You may at any time, in accordance with applicable laws, apply to us in writing for information on what, if any, personal data is held by us in your regard. We shall then inform you accordingly. Please direct any such requests to us. The latter should also be contacted should you wish to modify or delete your data.

Data security

Any data you supply to GoBali (Go Abroad Study Programs) will be protected by appropriate technical and organisational security measures in order to safeguard your personal data against accidental or intentional manipulation, loss, destruction or unauthorised access or disclosure to third parties. Our security measures are continually monitored and enhanced as new technology and organisational capabilities become available.
